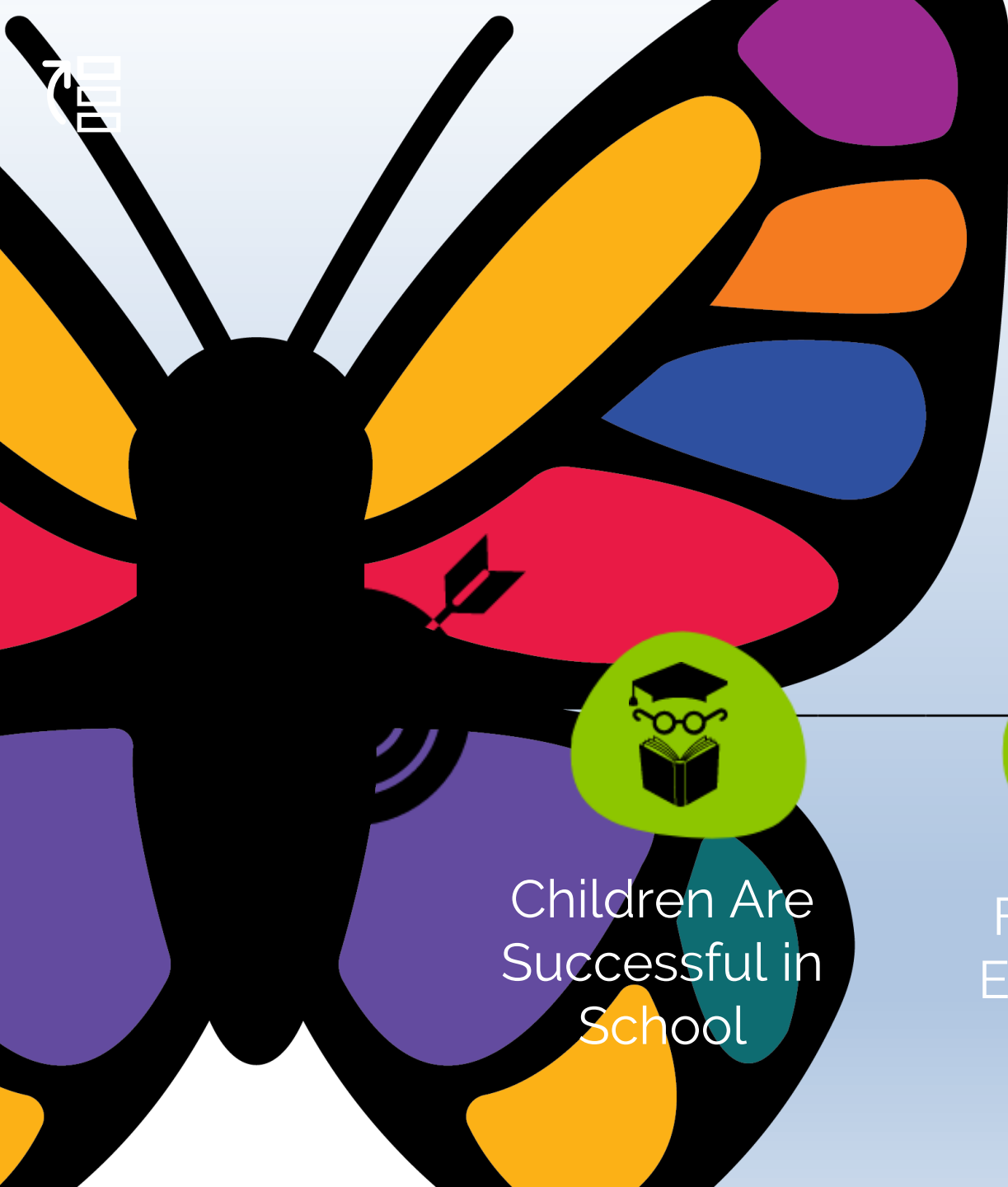

Adaptive Village

In response to the findings of an extensive Community Health Needs Assessment (CHNA) conducted in collaboration with Morgan State University's School of Community Health and Policy, Family League is proud to announce the Adaptive Village Small Grants program. This funding opportunity is aimed at supporting innovative projects that address critical health needs within target communities.

Project Description

Through the Adaptive Village Small Grants program, we aim to support community-driven initiatives that promote health equity and improve overall well-being. By investing in grassroots efforts and leveraging local expertise, we believe we can create lasting positive change in our communities.

Examples from last year include:

Catherines Family and Youth Services:

- Expanded their Food Pantry and Diaper Hub, introducing healthier food choices.
- Innovatively incorporated a refrigerated vending machine accepting EBT and debit cards.

Sharp Arrows:

- Collaborated with high school students and local partners to distribute Confidence Kickstarter Boxes.
- Established partnerships with local elementary schools, positively impacting mental well-being among youth.

No Boundaries Coalition:

- Conducted the Fresh WFD Program with a 60% completion rate.
- Eighty percent of participants obtained their ServSafe Manager Certification and secured employment in the culinary industry.



Reporting Requirements

All reporting is submitted via the Grants Management System, FUNDINGtrack (Fluxx):

Expense Report

- A line-item report of all program costs

Program Narrative Report

- Respond to narrative questions about the program
- Include the number of participants for people served/reached

Payment Structure

- **Advance Payment (50% of total award amount) is issued when:**
 - The Award Letter and Contract are signed;
 - All Administrative Contracting Documentation is received and approved;
 - All required financial forms (W-9, Electronic Funds Transfer (EFT) Form, cancelled check/confirmation letter from bank are received and approved.
- **Reimbursement Payment (up to 50% of total award amount) is issued when the Program Narrative Report and Final Expense Report is received and approved.**
- **All payments are issued via EFT to the name/organization indicated on the required financial forms indicated above.**

Application Requirements

Project applications, which will only be accepted via FUNDINGtrack, must include:

1. Identification of the Maryland Child Well Being Result Area being addressed:
 - Children are Successful in School
 - Families are Economically Stable
 - Communities are Safe for Children, Youth and Families
2. A brief description of the project, including objectives and expected outcomes
3. Details of the community and rationale for project selection
4. A comprehensive project budget outlining requested funding and expenses

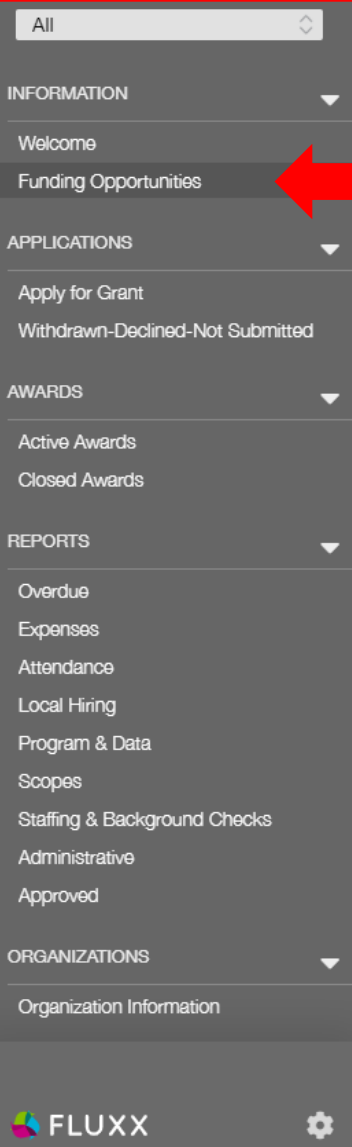
