ENOUGH Initiative

The Engaging Neighborhoods, Organizations, Unions, Governments, and Households (ENOUGH) Act of 2024

On May 9, Gov. Moore signs the ENOUGH Act into law to directly address concentrated poverty in Maryland's marginalized communities.



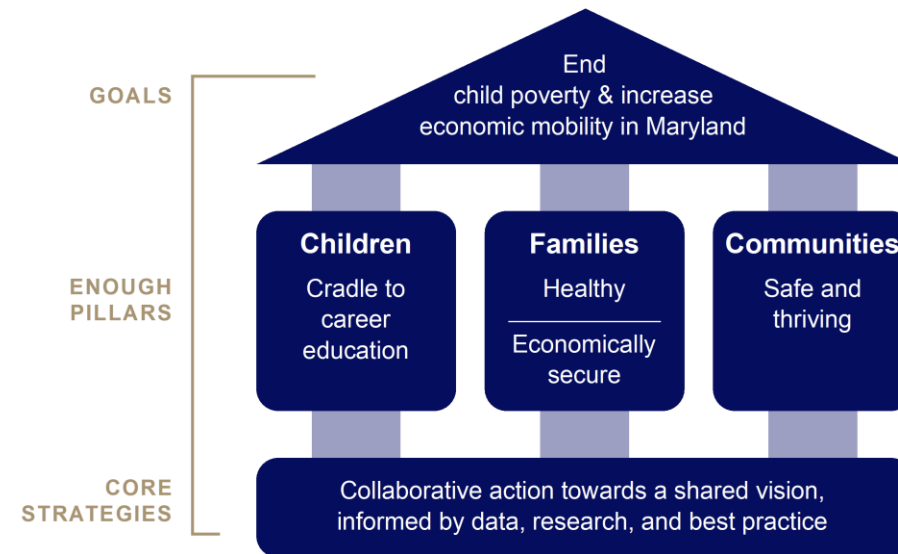
ENOUGH Initiative, a first-of-its-kind, community-based strategy to address concentrated child poverty in MD

On July 10, Gov. Moore and GOC announce the official launch of the initiative with a \$20 million investment towards funding and technical support for communities most in need to develop solutions to deeply rooted challenges.

ENOUGH Initiative

The ENOUGH Theory of Action calls for cross-sector, diverse partnerships to engage in collaborative action with community residents to drive decisions for place-based investments and strategies that increase economic mobility to end child poverty in Maryland.

ENOUGH Theory of Action



Priority Result Areas



Cradle to Career Education

Unlocking children's potential through early care and education from birth until working in a career, specifically ensuring smooth transitions through kindergarten, middle school, and high school graduation with a pathway to college and/or career.



Healthy Families

Ensuring community member and family access to high-quality, comprehensive healthcare with goals of decreasing infant mortality, increasing life expectancy, and improving behavioral health, which includes mental health.



Economic Secure Families

Ensuring higher employment and entrepreneurship resulting in livable and family-sustaining wages, and stable, thriving households where families can provide for necessities, weather hard times, and build wealth.



Safe and Thriving Communities

Creating communities where residents feel safe and where the built environment supports their ability to thrive, including high-quality, affordable housing; a thriving commercial core; and access to recreational spaces, nutritious food, and transportation.

ENOUGH Grant Program

For FY25, GOC has budgeted \$15 million to cover the costs of the ENOUGH Grant Program and an additional \$5 million for LMBs to support community-based organizations in building capacity for vital revitalization initiatives across the state.

ENOUGH grants will be issued along three (3) competitive tracks, and community capacity-building grants will be awarded to LMBs to **create a fully executed neighborhood action plan.**

TRACK 1: PARTNERSHIP DEVELOPMENT GRANTS

Max Award Amount: \$65K

Project Period: 6-12 months

Estimated/Expected Number of FY25 Awards: Up to 10

TRACK 2: PLAN DEVELOPMENT GRANTS

Max Award Amount: \$300K

Project Period: 12-24 months

Estimated/Expected Number of FY25 Awards: Up to 7

TRACK 3: IMPLEMENTATION GRANTS

Max Award Amount: \$5M

Project Period: 12-24 months

Estimated/Expected Number of FY25 Awards: Up to 3

Participant Eligibility and Criteria to Apply for Each Program Track

MEETS COMMUNITY ELIGIBILITY CRITERIA

-Communities that have at least one U.S. Census tract where more than 30% of children are living in poverty AND is served by a community school with a concentration of poverty level of at least 80%

COMMUNITY QUARTERBACK

-Community-led organization with resources and capacity to lead ENOUGH activities and manage ENOUGH funds, in coordination with community partners

PARTNERSHIP COLLABORATIVE

-A robust partnership of community-led organizations representing each of the ENOUGH results areas

-An established partnership governance structure to ensure alignment, information sharing, and resource deployment

COMMUNITY NEEDS ASSESSMENT

-Completed needs assessment identifying assets and gaps, informed by community data and residents' input

NEIGHBORHOOD ACTION PLAN

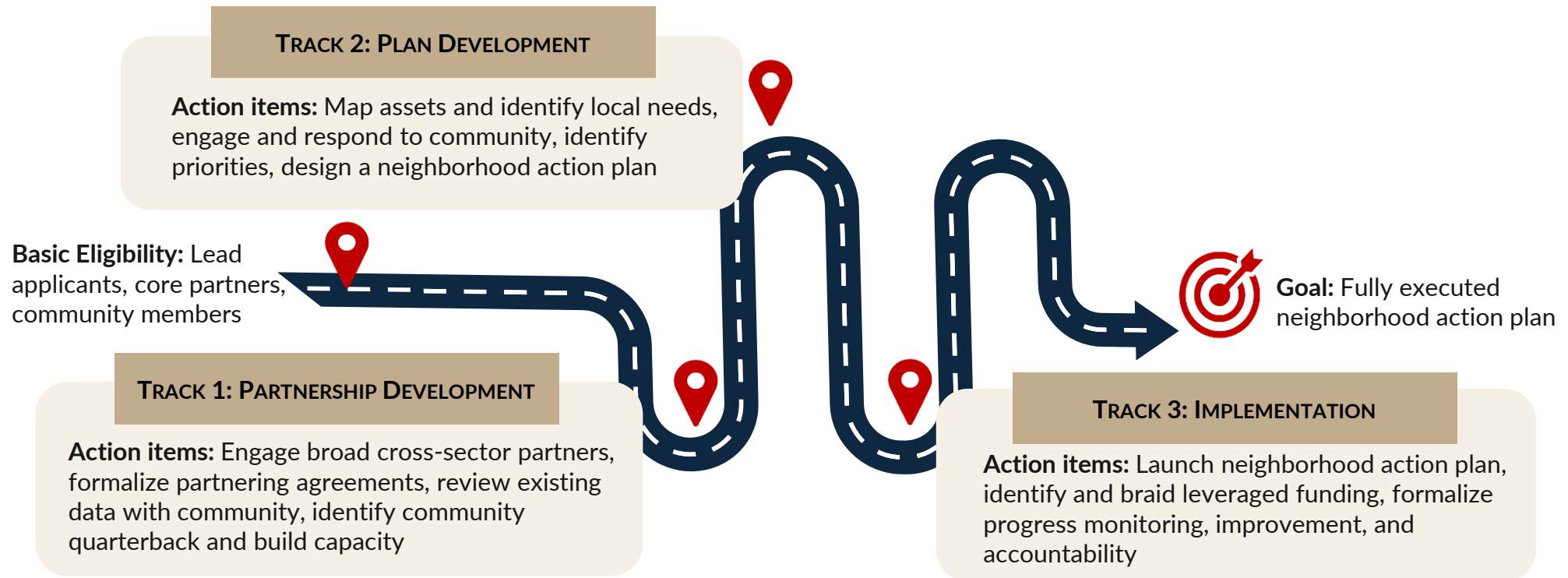
-An action plan that leverages various funding streams to address gaps identified in the needs assessment and provide a continuum of services for the community across ENOUGH result areas

Timeline and Application Process

APPLICATION DUE DATES

Track 1 Applications Due:	November 1, 2024
Track 2 Applications Due:	September 20, 2024
Track 3 Applications Due:	September 20, 2024
Grant Award Notifications:	Winter 2024 (All Tracks)

-The second round of funding (Year 2) is anticipated to begin in early Fall 2025. The ENOUGH Grant Program Notice of Funding Opportunity (NOFO) for Year 2 will be released Spring 2025.

REQUIREMENTS:

- **One grant per community.** It is very unlikely that GOC will make more than one award per community. Approximately 20 total to be awarded statewide.
- Ideally organizations serving the **same geography will submit a single, collaborative proposal** that reflects community-identified priorities.
- **One lead organization (community quarterback) and one ENOUGH track per application**
- **Each application must submit a robust set of partners.** GOC requires each community to identify one lead applicant along with several core partners.

LOOKING FORWARD:

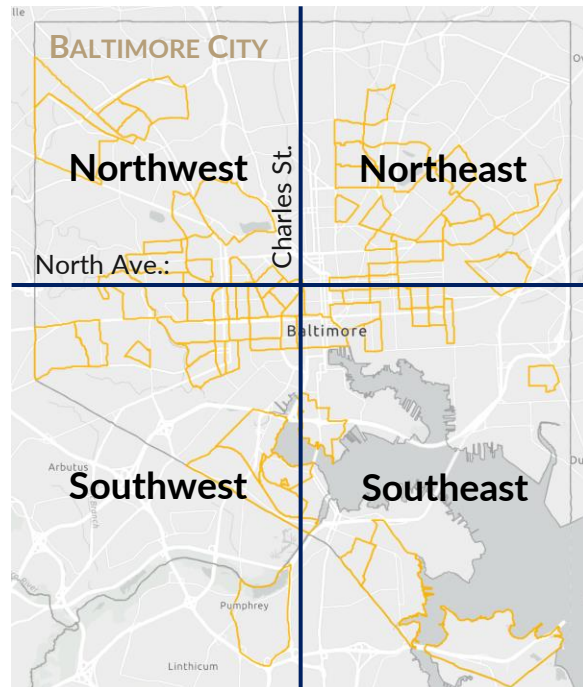
- **There will be future opportunities to apply for the next track.** Pending availability of funds, Track 1: Partnership Development and Track 2: Plan Development grantees will have the opportunity to apply for the subsequent track.
- To move from one track to the next, the ENOUGH community must demonstrate that they meet all the eligibility criteria of that track.
