Community Health Needs Assessment



Family League of Baltimore (Family League) is seeking proposals from qualified suppliers to conduct a comprehensive community health needs assessment (CHNA). This evaluation will involve examining existing data and gathering primary data via key informant interviews and focus group discussions in chosen communities. The goal is to capture current community challenges, strengths, and available resources within Baltimore City.



Project Description

The selected vendor will be responsible for the following:

- Review and analysis of existing quantitative data related to Baltimore City, including Maryland's 8 indicators of child well-being (babies born healthy, healthy children, school readiness, school success, school completion, school transition, safety, and stability) and socioeconomic indicators;
- Collection of primary data via key informant interviews and focus groups;
- Integration of frameworks;
- Identification of resources and community assets; and
- Data stratification.



Project Description

Project deliverables will include:

- Final Assessment Planning and Approval
- Secondary Data Analysis/Tabulation
- Primary Data Collection
- Data Convergence
- Draft Report summarizing findings and insights

Applicant Eligibility



Applicant Qualifications

The applicant must meet the following qualifications:

- Demonstrated experience in conducting similar work on behalf of public or nonprofit human services agencies;
- Expertise in social determinants affecting marginalized communities; and
- Ability to present, analyze, and disaggregate data by race as well as social and economic standing.

Data Security and Confidentiality

As detailed in the RFP, the selected vendor must adhere to the highest standards of data security and confidentiality.

Stakeholder Engagement

The applicant must be equipped to engage with key stakeholders throughout the assessment including data collection, regular updates, and presentation of findings.

Submission Requirements



In order to receive consideration, submissions **must** include:

- Responses to all questions;
- A clear, concise budget that does not exceed \$60,000.00 (PDF or Excel);
- Certificate of Good Standing with the State of Maryland **dated within the past 30 days** (available at <https://dat.maryland.gov/businesses/Pages/Internet-Certificate-of-Status.aspx>);
- Audited Financial Statements (\$50,000 or higher request) or Form 990 (under \$50,000 request) **dated within the past 12 months**;
- Resume'(s)/Bio(s) of staff planning to participate in the project;
- One to two work samples that align with the proposed project; and
- Letter(s) of Reference from organizations doing work similar to Family League **dated within the past 12 months**.

***Family League will also schedule presentations with eligible organizations as part of the review process.**

Selection Criteria

In addition to reviewing the required supplementary documentation, applications will be evaluated on the degree to which they:

- Adhere to proposal requirements;
- Demonstrate experience and expertise in community-based research particularly around social determinants of health;
- Describe the proposed project plan and timeline, including methodologies to be used;
- Demonstrate adequate, qualified staffing to successfully complete the project;
- Demonstrate commitment to Diversity, Equity & Inclusion.
- Include and prioritize community engagement at all phases of the project; and
- Offer pricing competitiveness and transparency.

Submission Requirements



- Applicants are required to submit applications through **FUNDINGtrack**, Family League's online grants management system accessible through <https://flb.flux.io>
- Applicants must be registered in **FUNDINGtrack**.
- *Applications must be submitted by 4:00pm on **February 7, 2025. EXTENDED***
- **Applicants are highly encouraged to register early!**
