

# New Findings From Baltimore City ECAC Highlight Critical Barriers to Access

Recent landscape analysis reveals significant disparities with quality early learning programs across the city

Baltimore, MD (June 26, 2025) – Family League, a key coalition partner in the Baltimore City Early Childhood Advisory Council (ECAC), today emphasized the urgent findings of the newly released "Baltimore City Early Care and Education Landscape Analysis: Supply, Demand, Obstacles and Opportunities." The comprehensive report reveals significant disparities in access to quality early learning programs for Baltimore's youngest students, underscoring critical shortages that threaten family economic stability and children's school readiness.

The analysis, conducted by <u>Baltimore City ECAC</u> in coordination with the <u>Maryland State Department of Education's state-level Early Childhood Advisory Council</u>, provides critical data to support the ongoing collaborative efforts of Baltimore City Schools, the Mayor's Office of Children & Family Success, Family League, and other community partners who are actively working to strengthen early childhood education access across Baltimore.

"The 2025 Landscape Analysis confirms what many of us working in early childhood have long understood: families in Baltimore face real and persistent barriers to accessing quality care and education. But the report highlights real strengths—dedicated providers and community partnerships that are already making a difference. This is a critical moment. With the right investments and coordinated action, we can build a more effective early childhood system for all of Baltimore's children," says Imani-Angela Rose, ECAC Co-Chair, Executive Director of Joshua's Place Early Learning Education Center and second Vice President of the Board of Maryland State Child Care Association.

Together, we've created a comprehensive tool that will help ensure more Baltimore children and families can truly thrive."

## **Report Findings Reveal Deep Inequities**

The Baltimore City ECAC analysis found alarming gaps in early childhood education access:

- Severe Capacity Constraints: In Baltimore City, there are only enough licensed child care for 20% toddlers and babies aged 2 and under. Just 50% of all children under 5 are served by existing programs, and prekindergarten is available for only 65% of 4-year olds—and almost not at all for 3-year olds.
- **Unaffordable Costs:** Families earning the median income or less spend over 30% of their income on child care. By federal standards, care is considered affordable at 7% of a family's income.



- **Economic Impact:** The lack of access to affordable care limits parents' ability to work. In Maryland, 80.8% of women with children under 6 participate in the workforce, according to the report.
- **School Readiness Disparities:** Children in formal early learning programs are two to three times more likely to be school-ready than in informal or home care, researchers found.

## Family League's Collaborative Role in Supporting Early Childhood Research

As a committed partner of the Baltimore City ECAC, Family League has worked alongside coalition members to help facilitate this comprehensive analysis. The organization contributed to the research effort through its funding partnership with the Maryland State Department of Education, while also providing coordination support through its ongoing School Readiness programming and community engagement initiatives.

The Baltimore City ECAC operates under the Maryland State Department of Education framework, ensuring coordination between local findings and statewide early childhood priorities. This structure enables Family League and other partners to work collaboratively across governmental levels while maintaining focus on Baltimore's specific needs.

# **Comprehensive Recommendations for Action**

The coalition urges city and state leaders to make early childhood education a top priority through:

- **Strategic Investment:** Fully fund prekindergarten expansion for all 4-year olds and low-income 3-year olds; especially in underserved areas; and raise caregiver wages to stabilize the workforce.
- **System Improvements:** Secure long-term funding for Maryland Child Care Scholarship Program and eliminate roadblocks to provider participation in prekindergarten and quality rating systems.
- **Enhanced Data Systems:** Create an identifier to track enrollment and readiness across care settings, with education officials regularly collecting and sharing enrollment and capacity data.

## **Future Research and Community Engagement**

This report represents the first in a series by Baltimore ECAC and future research will explore early childhood experiences from birth to age 5, including parent and caregiver perspectives through surveys and focus groups—ensuring community voices remain central to solution development.

Family League will continue its collaborative leadership through the council, supporting evidence-based policy development and working alongside state partners and community stakeholders to transform early childhood education access in Baltimore.
